


- 1. Lori Wells provided a district-wide breakdown and comparison of MEAP scores for Gladstone, the ISD, and State. With the changes in the cut-scores, our district scores took a hit. We will be using the improved tools that we have, like Data Director and Curriculum Crafter, to dig deeper into the data to address any deficiencies. Looking ahead at the big picture, we will continue to evaluate 'the whole student' to measure our district's success, while at the same time attending to those test scores that are most appropriate for our students' success.
- 2. As you are all aware, I worked diligently with the building principals, in collaboration with the GEA leadership, to put a staffing plan together for next year that kept all of our current staff in place, except for Mrs. Lundin. Prior to making the rounds of each building to explain the staffing decisions, I explained to the GEA membership that the arbitration case could cause some serious wrinkles in the plan. I stated that if the arbitration were to happen as scheduled, then the issue of lay-offs would need to be revisited in order to fully protect the interests of the District. They chose to move forward with the arbitration, which occurred this past Monday.

When I met with the GEA leadership last week on the 10th to discuss the potential need for lay-off notices due to the uncertainty of the arbitration, the information that I was working with was incomplete. Whereas I had expressed that the District must prepare for the worst-case scenario, rather than moving forward with keeping all current teaching staff [except Mrs. Lundin], I was basing my calculations on the most accurate information I had at the time. Specifically, I was under the impression that the scheduled arbitration hearing would find the union claiming that a teacher may be due re-instatement and back pay, since Sue Weyers was mentioned during the mediation in December.

Now that we have had the hearing, it is clear that the worst-case scenario has changed significantly. I am now under the impression that the union claims that there may be three teachers who are due re-instatement and back pay. Even though I believe strongly that this assertion has no merit, I am compelled to protect the interests of the District. For this reason, the list of potential lay-offs and reduction notifications has grown dramatically. At this time, the current State legislation provides the controlling language on the process.

Based on my conversations with the principals, the appropriate notifications consist of the following:

Lay-off –
Paula Lundin; position elimination 2/5 HS Chemistry
Bruce Murray; position elimination HS Special Ed.
Marci Downey; position elimination 3rd grade
Neil Gerber; low performing MS
Chris Saari; low performing Cameron
